CAN'S MISSION IS TO RAISE AWARENESS ON CHILD RIGHTS AND PROMOTE CHILD PARTICIPATION, ADVOCATE AND PROTECT CHILD RIGHTS, MONITOR AND SUGGEST RECOMMENDATIONS TO THE IMPLEMENTATION OF CHILD RIGHTS AND PARTICIPATION, AND DEVELOP AND COORDINATE THE CAPACITY BUILDING OF CAN'S MEMBERS.

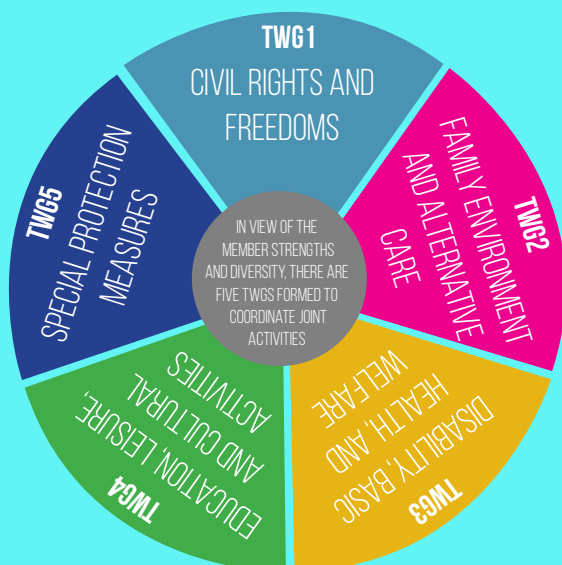
### AYRG

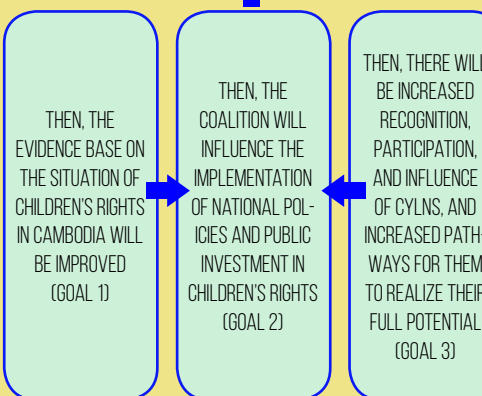
